

Privacy Statement The International Leafy Vegetables databases

Welcome to the International Leafy Vegetables databases. This Website is part of Wageningen University & Research (WUR) and focuses on the plant genetic resources of lettuce, spinach, chicory and minor leafy vegetables. With this Privacy Statement, WUR indicates which personal data is collected and for which purpose. In addition, you can read about your rights as a data subject and how to contact us.

What we do with your personal data

The International Leafy Vegetables databases collects certain personal data obtained through the use of our Website. This data has been collected for the following purposes:

1. Improving our Website; such as IP address, date and time of visit;

Do we share personal data?

As a general principle, the International Leafy Vegetables databases does not disclose your personal data to third parties, unless this is necessary for the provision of a service. This means that, for example, we try to minimize the use of Cookies and keep the sharing of data with partners to a minimum.

An important exception is the sharing of personal data when it is required under applicable law or in course of any legal proceedings. In that case, the International Leafy Vegetables databases must share data with authoritative bodies, for example with law enforcement. This will occur, however, under supervision of a privacy officer.

How long we retain your data

No personal data is recorded and therefore not stored through this Website. Data necessary for the functioning of this Website will be deleted after closing the Website.

How do we protect your personal data?

Obviously, the processing of personal data includes appropriate security measures. Therefore, this Website is secured and we also demand that of our partners. WUR's starting point is NEN-EN-ISO/IEC 27002:2017 to make sure that personal data is optimally secured. Additionally, the International Leafy Vegetables databases also monitors whether there are unlawful traffic or activities on the website.
